

Regular Meeting Minutes

The Wahoo Board of Education met in regular session on Monday, April 19, 2021 at 6:00 p.m. in the High School Media Center located at 2201 N. Locust, Wahoo, Nebraska. Publicized notice was given by publication in the Wahoo Newspaper on Wednesday, March 10th and posted on the school's website and doors.

The meeting was opened by Superintendent Lavaley with the following board members answering roll call: Rob Brigham, Mike Hancock, Brett Eddie, Lora Iversen, Alex Shada and Renae Feilmeier. Also present were Superintendent, Brandon Lavaley; Secretary, Kris Pokorny; Elementary Principal, Ben Kreifels; Middle School Principal, Marc Kaminski; High School Principal, Vernon Golladay, Asst. Principal/Athletic Director, Robert Barry; Director of Learning, Josh Snyder; Director of Student Services, Shelley Maass and WEA representatives Judy Stukenholtz and Lisa Russ, the Wahoo Newspaper Reporter and a few patrons.

The open meetings law was mentioned and the open meetings law poster is displayed.

The Board of Education said the Pledge of Allegiance.

A motion was made by Hancock, seconded by Eddie to approve the agenda. On roll call vote all members present voted yes. Motion carried.

A motion was made by Iversen, seconded by Hancock to approve the Regular Meeting minutes of March 15, 2021 as submitted. On roll call vote all members present voted yes. Motion carried.

A motion was made by Iversen, seconded by Hancock to approve payment of the April 2021 claims as presented. On roll call vote all members present voted yes. Motion carried.

The board reviewed the account funds and balances related to the routine business of the school district pertaining to the accounts the district controls.

The Principals, Director of Learning, Director of Student Services, Athletic Director and Superintendent gave informational reports to the board.

Superintendent Lavaley spoke about the current Legislative session and to keep a close eye on the upcoming bills and what they will mean to the school district.

Brett Eddie and Rob Brigham will represent the board at graduation this year.

The Wahoo Public Schools Foundation Committee met this month and elected officers.

During the Public Comments section of the meeting Kyle Cooper addressed the board.

A motion was made by Shada, seconded by Hancock to approve the purchase of iPads and cases for the Middle School for an amount not to exceed \$141,385.00. On roll call vote all members present voted yes. Motion carried.

It was moved by Hancock, seconded by Shada to approve the hiring of Brandon Zetocka for the Middle School Social Science teacher and Whitney Swanson for the Birth to 5 Speech Pathologist. On roll call vote all members present voted yes. Motion carried.
